



Parent/Guardian permission to participate in girls addicted to basketball's "20th Anniversary Gymnasium Competition" program on June 20, 2025

ASSUMPTION OF RISK, RELEASE, WAIVER, CONSENT AND INDEMNITY:

I hereby agree, in return for becoming a registered member of Girls Addicted to Basketball ("g.a.b") and the participation in any practices, training, games, events, programs, and/or activities organized, operated, conducted or sanctioned by g.a.b alone or with another organization (each a "g.a.b program"):

- THAT I AM assuming the risk of transmission and storage of personal information over various electronic systems, despite g.a.b's best efforts to secure such information, breaches may occur due to various factors beyond its control, including but not limited to cyber-attacks, system failures, or unauthorized access;
- THAT THE World Health Organization has classified the Coronavirus Disease ("COVID-19") outbreak as a global pandemic and I am aware of the risks of COVID-19, and the risks to personal health, including by the failure to follow physical distancing, flowing from COVID-19;
- THAT I AM assuming all health risks and adverse health-related consequences, including without limitation COVID-19, to me and the child and or children named below caused by or arising from engaging in any g.a.b programs (the "Assumed Risks");
- TO RELEASE g.a.b, event organization bodies, sanctioning bodies and g.a.b sponsors and their respective directors, officers, employees, agents, volunteers, contractors, representatives, officials, successors or assigns (collectively the "Releasees") from any liability for any loss, damage, injury or expense (collectively "Loss") that I or my child or children may suffer arising out of or connected with the Assumed Risks and/or my participation or my child or children's participation in any g.a.b program, due to any cause, including negligence;
- TO WAIVE ANY CLAIM that I have or may have against any or all of the Releasees regarding any matter, including without limitation, any claim arising out of any g.a.b program
- TO INDEMNIFY THE RELEASEES from any and all claims, actions, or Loss resulting in any way from my participation or participation of the child or children named below in any g.a.b program;
- THAT I am and the child and/or children's names listed below is physically fit to participate in any g.a.b programs;
- THAT I am of legal age and/or the legal guardian and/or custodial parent of the child and/or children's names below;
- THAT I authorized g.a.b, its officers, directors, members, agents, contractors, and media persons that g.a.b elicits to record personal information, images, and audio recordings in any medium of me, the child, or children named below at or in relation to any g.a.b program for publicity and promotional purposes in perpetuity, and I hereby consent to the collection, use, and disclosure of such personal information about me and/or the child and/or children named below;
- TO CONDUCT myself and my child or children named below as set out in accordance with the "Parent/Guardian & Participant Agreement" below at g.a.b sanctioned events;
- THIS DOCUMENT SHALL bind my heirs, executors, administrators, assigns, and personal representatives and will have effect throughout my participation at g.a.b and, to the extent reasonably necessary to give it effect, thereafter;



LIABILITY WAIVER:

I give my consent as an adult and or parent for my participation and my child and/or children's participation as named below in **girls addicted to basketball** (g.a.b) program activities.

The risk of injury for the activities involved in the "20th Anniversary Gymnasium Competition" program is significant including the potential for permanent paralysis and death, while particular rules, equipment and personal disciplines may reduce the risk, the risk of serious injury does exist, and,

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the organizers and any staff member or official, their directors, members, coaches, officials, agents, and employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the "20th Anniversary Gymnasium Competition" program ("Releasees") and I assume full responsibility for my participation, and, my child and/or children's participation as named below.

I agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation in the "20th Anniversary Gymnasium Competition" program, I will remove myself and my child and/or children from participation and bring such to the attention of the nearest official immediately.

I accept the risks for injuries, which may be suffered by myself and I agree that the Association, its Directors, Members, Coaches and Agents shall not be liable nor responsible in any manner whatsoever for any damages resulting from any injuries to myself, however caused including by an act of negligence.

Loitering:

Health:

Participant **agrees to stay home if participant is experiencing one of the "COVID-19" symptoms.** Participant is to bring an epi-pen throughout the duration of the "Fit & Flow" program if participant has allergies. Participant agrees to bring a puffer that is not expired throughout the duration of the "Fit & Flow" program if participant is asthmatic.

Safety:

Participant agrees to act appropriately in a manner that is not threatening and or discouraging to self and other participants, officials, scorekeepers, administrators, coordinators, volunteers, instructors, g.a.b media personnel and the Director. Participant agrees to wear athletic shoes with laces.

Concussions (Rowan's Law):

Participant acknowledges they have read the Ministry of Tourism, Culture & Sport (MTCS) **Concussion Facts & Guide AND** have **read Ontario Basketball's Concussion policy AND** agree to follow the policy and guidelines. These materials are attached to this waiver/agreement that was issued to you online at the time of registration.

Personal Care For Competition:

Participant agrees to **remove all jewellery and ear pods/ear devices** during active participation for basketball only and agrees to have their **fingernails cut** to an acceptable length that will not cause any bodily harm against another participant in the event of an accident.

Fair Play For Basketball Session:

Participant agrees to participate in the basketball session and **respect the foul calls** that may be called out against them without retort, or threatening words and or body language. Participant agrees to participate in **equal playing time** and volunteers to sub themselves off to allow for other participants waiting to join in.

By signing below, the participant acknowledges they have read and understood the conditions and certify to abide by the loitering, health, safety, **concussions** personal care, and fair play agreements listed above. Failure to meet the above agreements will result in the removal of the participant's participation for the remainder of the program at the sole discretion of the Director.
