-THAT THE World Health Organization has classified the Coronavirus Disease ("COVID-19") outbreak as a global pandemic and I am aware of the risks of COVID-19, and the risks to personal health, including by the failure to follow physical distancing, flowing from COVID-19;

-THAT I AM assuming all health risks and adverse health-related consequences, including without limitation COVID-19, to me and the child and or children named below caused by or arising from engaging in any g.a.b programs (the "Assumed Risks");

- TO INDEMNIFY THE RELEASEES from any and all claims, actions, or Loss resulting in any way from my participation or participation of the child or children named below in any g.a.b program;

- THAT I am (or the child or children's names below is) physically fit to participate in any g.a.b programs;

Parent/Guardian and Participant Agreement (Friends & Family program)

Loitering:

Participant and parent(s)/guardian(s) agree to enter Senator O'Connor's parking lot any time after 6:15pm and will leave before 9:10pm. If participant is a student at Senator O'Connor, she must not wait at school until 6:00pm for the program to start. She must leave the building and its property and return any time after 6:15pm. Participant and parent(s)/guardian(s) agree to refrain from loitering inside the school hallways during instruction or competition. **Students from Senator O'Connor cannot access their lockers.**

Health:

Participant and parent(s)/guardian(s) **agree to bring the "COVID-19 Attestation" form signed.** Should the participant experience one symptom, they are to stay at home. Participant is to bring an epi-pen throughout the duration of the "Friends & Family" program if participant has allergies. Participant and parent(s) agree to bring a puffer that is not expired throughout the duration of the "Friends & Family" program if participant is asthmatic.

Safety:

Participant and parent(s)/guardian(s) agree to act appropriately in a manner that is not threatening and or discouraging to self and other participants, coaches, spectators, officials, scorekeepers, administrators, coordinators and the Director. **Therefore, the use of cell phones, smart phones or any other devices to record, film, or take pictures during the program is not allowed (prohibited).**

Concussions (Rowan's Law):

Participant and parent(s)/guardian(s) acknowledge they have read the Ministry of Tourism, Culture & Sport (MTCS) **Concussion Facts & Guide** for Parents **AND** have **read Ontario Basketball's Concussion policy AND** agree to follow the policy and guidelines. These materials are attached to this waiver/agreement that was sent to your email.

Fans/Friends:

Participant and parent(s)/guardian(s) agree not to bring any fans/friends to the "Family & Friends" program unless they are the "1 invite female friend". Immediate family is defined as a sibling, mother, or father or partner of the parent/guardian. Special circumstances will be considered at the sole discretion of the Director.

By signing below, the participant and parent(s)/guardian(s) acknowledges they have read and understand the conditions and certify to abide by the loitering, health, safety, **concussions** and fans agreements listed above. Failure to meet the above agreements will result in the removal of the participant and her parent(s)/guardian(s) participation for that day or for the entire duration of the program at the sole discretion of the Director. The participant and parent(s)/guardian(s) accept that NO REFUNDS will be awarded should the participant and parent(s)/guardian(s) be removed for a day or for the entire program.
